### PLEASE READ AND INITIAL EACH PROVISION BELOW

1. \_\_\_\_ I release Woof Central, LLC of any liability arising from my dog's attendance and participation in activities.
2. \_\_\_\_ I fully accept all reasonable risks of illness or injury that may be incurred during normal daycare activity. Such risks include, but are not limited to: cuts, scrapes, and other minor injuries resulting from rough play and possible contagious illnesses such as upper respiratory infections (of which only one, "bordetella," currently has a vaccination available).
3. \_\_\_\_ Woof Central agrees to exercise due and reasonable care in the handling of dogs, and in keeping the facility properly enclosed and sanitary. All dogs are cared for by Woof Central staff without liability on Woof Central's part for loss or damage from disease, theft, fire, death, escape, injury, or harm to persons, other dogs, property, or for other unavoidable causes, due care and diligence having been exercised.
4. \_\_\_\_ I understand that I am solely responsible for any harm caused by my dog, while my dog is attending Woof Central, provided reasonable care and precautions are followed by Woof Central's staff.
5. \_\_\_\_ I shall indemnify Woof Central against any claims made against the company, or any losses or damage of any kind suffered by Woof Central as a result of my failure to inform Woof Central of any pre-existing condition my dog may have (including, but not limited to an illness or known aggression problem).
6. \_\_\_\_ I agree to keep my dog on monthly flea treatment (at least May - October) and to take precautions against contagious illness and parasite exposure by consulting with my veterinarian prior to my dog attending Woof Central.
7. \_\_\_\_ I understand that in the event of injury, Woof Central staff may or may not notify me immediately, at their discretion. If the injury is not serious, staff may allow my dog to continue to play, and then notify me when I come to pick up my dog. If the injury is serious, or requires that my dog be removed from group activities, I will be notified immediately.

8. \_\_\_\_ I understand and agree that should my dog become ill or in need of medical attention, Woof Central will first try to contact me. If unable to reach me in an emergency situation, Woof Central staff reserves the right and sole discretion to administer aid, and/or to use my designated veterinarian or any available veterinarian without liability, and I agree to promptly pay for all medical treatments received.

9. \_\_\_\_ I understand that my dog will only be released to the owner(s) on file, unless prior arrangements have been made, with a Woof Central staff member.

10. \_\_\_\_ I understand that if my dog is left at Woof Central for a period of 3 days past a scheduled pick-up date without contact from me or my authorized representative, my dog will be considered abandoned and all necessary steps will be taken to turn the dog over to the proper authorities and/or animal rescue agency.

11. \_\_\_\_ **Boarding Drop-off:** Our check-in times are Monday-Friday 7am-5pm, Saturday 8am-10am and 6pm-7pm, Sunday 8am-9am and 6pm-7pm. Checking in later than these times could result in a \$20 late check-in fee.

12. \_\_\_\_ **Late Charges Boarding:** Check-out time at Woof Central is from 7am to 10am Monday through Friday and 8am to 10am Saturday and Sunday. Dogs picked up later than 10am will be charged an additional fee. Hours of operation (subject to change) M-F 7a-7pm, Sat 8am-12noon & 6pm-8pm, Sunday 8am-10am & 6pm-8pm.

13. \_\_\_\_ **Late Charges Daycare:** \$5.00 for every 5 minutes or fraction thereof past closing. Late charges must be paid at the time of late pick up. If your dog has still not been picked up 7:05pm he/she will be bedded down for the night and full overnight charges will be assessed and must be paid before your dog is released to you. Your dog may be picked up the following morning before 10:00am to avoid additional charges. Hours of operation are subject to change.

14. \_\_\_\_ I give Woof Central permission to use pictures of my dog(s) on their website or other advertising materials.
